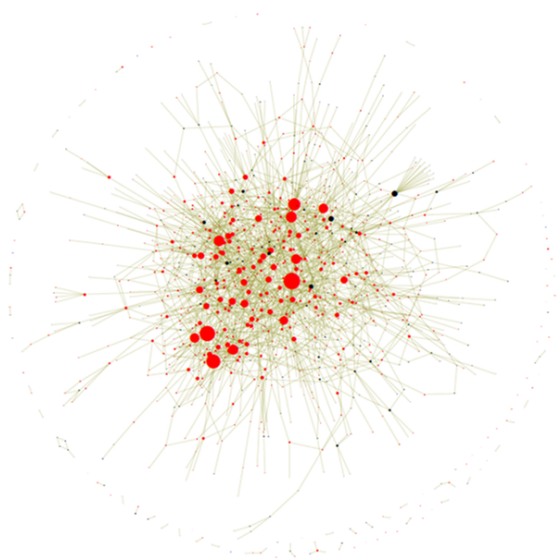

## SPOTLIGHT

### From corruption to state capture: a new analytical framework

A recent paper published by the Corruption Research Center Budapest offers an exciting new take on how to analyse state capture; a term which is widely debated and used, yet has so far largely escaped a precise analytical definition and measurement. The debate around state capture has so far centered on theoretical contributions while empirical studies were scarce and either relied on qualitative data lacking sufficient breath, or survey data lacking sufficient reliability. Using micro-level data on institutionalised grand corruption in public procurement, the

authors develop a new conceptual and analytical framework for gauging state capture.
